## **Position Description**

The University of Chicago's Department of Pathology in the Biological Sciences Division invites applications for a faculty position in Immunology. We will consider candidates whose research approaches immunology from any variety of organismal, cellular, molecular, computational or genomic perspectives, in animal models or in humans, in health or disease conditions. The appointment will be at the rank of tenure-track assistant professor or tenured associate professor.

The Immunology Faculty in the Department of Pathology are members of the interdepartmental Committee on Immunology, which provides a collaborative and highly multidisciplinary environment for research, training and teaching. The University is also committed to providing a strong environment for faculty mentoring and career development. Competitive research space and start-up funding will be available, as will the potential for interactions with off-campus affiliates, Argonne National Laboratory and the Marine Biological Laboratory. Most university divisions and centers are contained within one compact campus in Chicago's vibrant Hyde Park neighborhood.

Prior to the start of employment, qualified applicants must have a doctoral degree or equivalent. Assessment of applications will consider applicant's record of research in immunology or related fields. Application must be submitted through the University of Chicago's Academic Recruitment job board, which uses Interfolio to accept applications: http://apply.interfolio.com/95447. Applicants must upload: a cover letter, a CV including bibliography, contact information for three references, a research statement that outlines research goals and highlights up to three selected publications, and a teaching statement [which may also include the candidate's experience in teaching diverse students, if applicable (The University's Diversity Statement can be found at https://provost.uchicago.edu/statements-diversity)]. Each statement should be less than three pages in length. Review of complete applications will begin November 8, 2021, and continue until the position is filled.
